Deadline to register is October 1<sup>st</sup>, 2022, first-come, first served.

1. Bark in the Park hours are 11:00 a.m. to 3:00 p.m.
2. Public admission is free.
3. All items sold are subject to approval by event committee.
4. Vendors are responsible for setting up and cleaning up their space. Set-up starts at 9:00 a.m. with completion by 11:00 a.m. The vendor is responsible for set up, operation, maintaining and dismantling of the booth. The vendor shall clean up booth site and remove and dispose of trash. Vendors are to comply with all federal, state and local laws, rules and regulations and shall have appropriate licenses, permits, and other required documentation.
5. Vendors must receive event committee approval for items displayed/sold.
6. All media accepted.
7. TLC Humane Society, its representatives, and its members are not responsible for property damage or injuries incurred during Bark in the Park.
8. Vendor signature is required on the booth application indicates acceptance of these participation rules.
9. No application will be processed without full payment of registration fee. Vendor space is limited. Please submit your application as soon as possible.
